WHAT IS RPL?

Recognition of Prior Learning [RPL] is a process that allows an individual's relevant prior learning [such as employment, training, relevant volunteering and life experience] to be assessed for the attainment of an ANZIIF qualification.

RPL candidates can use their existing skills and knowledge to achieve the required credits for a full or partial qualification.

Specific assessment requirements require that RPL candidates meet the same high standards of professionalism and skills as students who become qualified through the traditional education process

- Formal recognition of relevant previous experience
- Industry recognition as a skilled professional
- Opportunities for career advancement

Who can apply for RPL?

RPL is available to professionals who have five or more years' experience in the insurance industry. Professionals who may opt for RPL include those who:

- Want to obtain a qualification to meet professional requirements
- Don't need to study what they already know.

How long does the RPL process take?

The RPL process is flexible to your work and personal life. The duration of the process of compiling evidence varies depending on the individual. On average, the majority of RPL candidates gather evidence over a period of three to six months.

HOW TO APPLY



1. RPL expression of interest

- 1. Email rpl@anziif.com to enquire about RPL and provide the following:
 - · ANZIIF Master ID
 - Nominate / advise what you are seeking (i.e. an ANZIIF qualification)
 - · Detailed Curriculum Vitae (CV)
 - Current position description (PD)
 - · Statement of Attainment/s*
- 2. ANZIIF reviews the documents provided and determines eligibility.
- 3. ANZIIF arranges a pre-application discussion to assess your eligibility for RPL.
- 4. If eligible, ANZIIF will provide you with the RPL application form.

2. Application

- Should you wish to apply for RPL assessment, complete the RPL application form and make payment.
- ANZIIF will provide you with a customised RPL kit (including templates, forms and submission guidelines).



3. Submission

• Submit your portfolio of evidence.



4. Assessment and results

- Assessment is conducted by ANZIIF's qualified assessors in two stages, as follows:
- a. An assessment of your portfolio of evidence. Further evidence may be requested or training may be recommended if a skill or development gap is identified.
- b. An online interview.
- You will be advised of the outcome of your assessment
