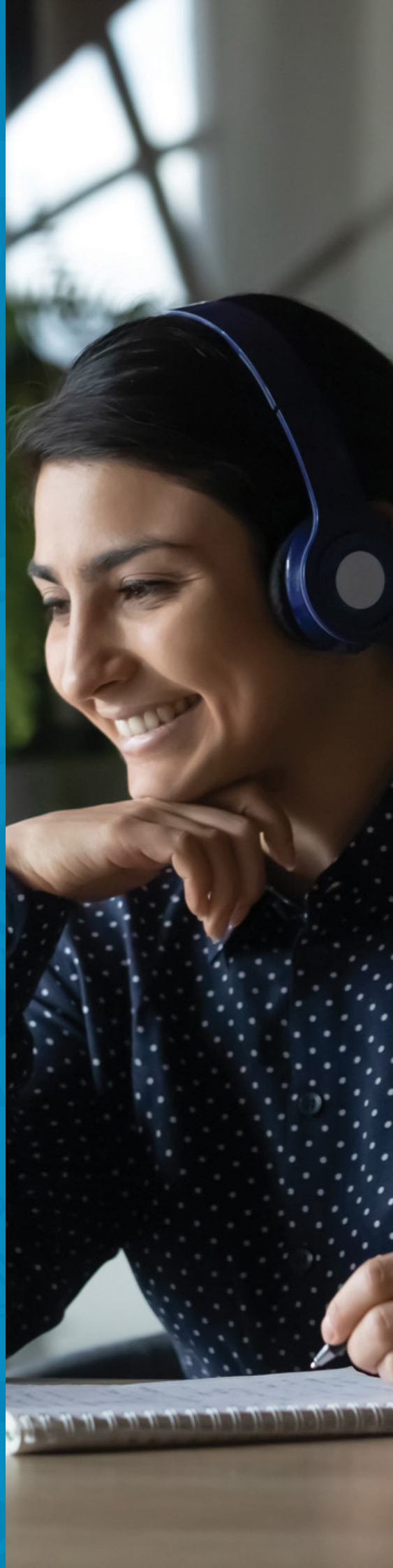

Certified Insurance Professional (CIP)

The ANZIIF CIP designation demonstrates a professional's commitment to a career in insurance.



CIP members must:

- Have an ANZIIF qualification or equivalent;
- Participate in 25 hours of professional development per year (25 CIP points); and
- Adhere to the ANZIIF Code of Ethics.

ANZIIF provides an extensive library of technical articles, interactive online activities, a range of professional development events, and courses and qualifications to help members reach their 25 CIP points per year.

CIP Member Digital Badge

ANZIIF have partnered with Credly to provide CIP members with a digital badge – a new way to validate skills and achievements digitally. CIP Members can now share this achievement with employers, clients, peers and the industry digitally.



Professional Development

Professional Development opportunities ensure that members retain the high level of expertise and knowledge essential for reaching their career goals.

Professional Development Content

Designed to maintain and develop skills and knowledge, members have access to articles, interactive online activities, white papers and videos through ANZIIF's ever-growing Professional Development section on the website.

Skills Units

ANZIIF Skills Units are online, interactive courses based on real-world scenarios that focus on specific competencies and learning outcomes relevant to the individual's professional development needs. Skills Units can be completed in either five or seven weeks, with regular start dates.

Certificates & Qualifications

Skills Units can be combined in various ways to achieve ANZIIF Certificates – insurance-based qualifications representing industry standards of excellence. All ANZIIF Certificates are formally recognised, internationally portable and available in three levels:



ANZIIF also offers AQF qualifications (Certificate IV and Diploma) via Skills Units.

Compliance

ANZIIF offers a range of Australian Securities and Investments Commission Regulatory Guide 146 (ASIC RG146) compliance solutions for financial services professionals. Compliance options are available in General Insurance, Insurance Broking and Life Insurance.

Recognition of Prior Learning (RPL)

ANZIIF's Recognition of Prior Learning (RPL) allows the skills and knowledge previously gained through employment, training, volunteering and life experience to be put towards attainment of an ANZIIF qualification.
